Dates of Summer School: July 2 – July 24

8:00 am – 10:40 am; 10:45 am – 1:25 pm

Location: All classes will be delivered at Transcona Adult Learning Centre (130 Regent Avenue East)

Fees: \$190 per course. Fees must be included with the completed application form. Make cheques payable to River East Transcona School Division. Do not send cash in the mail. There will be a charge for NSF cheques.

Eligibility: Repeater students must have completed the course with a grade above 35% as verified by a report card. Instruction cannot be provided for students who require modified or EAL programming.

Registration Deadline: 4 p.m., Friday, June 28th. Registrations will be accepted on a first-come, first-served basis. Students should register early to improve their chance of getting a preferred course. Mail or drop off applications for summer school to: Adult and Continuing Education Office, 530 McLeod Ave., Winnipeg, MB, R2K 0B5. Late registrations will be accepted up to the third day of classes, i.e. July 4th, subject to availability. Applicants will be assessed a late fee of \$10.

Course Cancellations: River East Transcona School Division reserves the right to cancel courses for which there is insufficient enrolment. This means a course could be cancelled outright and the student will receive a full refund.

Refunds/Withdrawal Deadline: Thursday, July 4th: To receive a refund, the student must withdraw from the course by July 4th. To apply for a refund, the student must present their receipt, along with a letter from their parent or guardian indicating the reason for withdrawing, to the summer school office located at McLeod Education Centre. An administrative fee of \$20 will be deducted regardless of whether or not the student has attended any classes.

Parent-Teacher Meeting: Friday, July 12th: Parent-teacher meetings will be held the morning of July 12th. More details about this event will be sent home with students during the first week summer school is in session.

Report Cards: Report cards will be mailed to the home immediately following the conclusion of summer school. Copies of the reports will also be forwarded to the “sending” and “receiving” school.

Guidelines for Students

It is hoped that by choosing to attend summer school, you will earn the credits you require and improve your ability to meet the demands of high school. A team of highly conscientious and caring teachers is ready to help you meet these goals. They have prepared a program of activities intended to assist you in achieving two objectives: Improving your mark in the course for which you have enrolled and giving you a positive start to the new school year. Guidelines for your personal success are outlined briefly below. We trust you will respond positively to them.

Attendance Matters: Summer school classes are intensive learning opportunities. Attendance is compulsory, and evaluation activities are scheduled every day. Parents/guardians will be notified of unexcused absences. Students may be withdrawn after three days of unexcused absence, without refund of fee.

Assignments/Assessments: You are expected to complete all assignments and assessments as scheduled by your teacher.

Code of Conduct: You are expected to follow the code of conduct established by River East Transcona School Division. To read the code of conduct please go to: <http://www.retsd.mb.ca/site/about/code.html>

You are expected to dress appropriately. Hats and beach clothing are not acceptable.

You are expected to refrain from smoking anywhere on school property.

You are expected to take care of textbooks and other instructional material or equipment allocated to you and return these items to your teacher at the conclusion of summer school.

Daily Routine: You will receive a five-minute break each day. You are expected to remain on the school grounds during the break time.

In Case of Illness: In case you become ill at Summer School, you are expected to report first to your class teacher, then to the Summer School office. You should not leave the school without reporting to the Summer School office.

Personal Items: School lockers are not available. Cell phones and certain electronic devices cannot be used in the classroom.

You are responsible for the safekeeping of all personal items. Should you happen to lose any personal belongings (e.g. bicycle) you are responsible for notifying the appropriate authorities (police and your insurance company) immediately upon discovering the loss. Textbooks given to you for use during the Summer School must be returned in the same condition as you received them. Any damage or loss will necessitate reimbursement to the Summer School.
